

	Hoda Hamed has accomplished the most significant objectives of "women's writing" by emphasizing the significance of "women's gender" and pointing to all four dimensions of this gender's role—"psychological, linguistic, biological, and cultural"—which is consistent with Showalter's theory. Hamed has tried to be effective in the form of women's language to create and expand the role and rights of women in psychological, social and cultural dimensions. The author has effectively achieved a reflection of women's writing that highlights the social aspects of women's identity. Shawalter posits that the societal hegemonic culture exerts an effect on three additional approaches: biological, psychoanalytic, and linguistic. This means that the body, mind and language of women are also related to the culture of the society. Reflecting the various

dimensions of women, at the beginning of the novel, Hamed attaches more importance to the biological roles of women such as pregnancy, childbirth, etc. Its vitality has been strengthened and women have achieved success in altering their conditions. Under the influence of his gender, Hamed was able to comprehend the biological, psychoanalytic, and cultural aspects of women, and his language and gender reflected their concerns. Referring to the psychoanalytic dimension of women, Hamed seeks to highlight the concept of "gender" and sexuality.

Prioritizing the expression of women's cultural and social concerns and problems in his language and literature, Hoda Hamed has uncovered issues that reveal serious and profound problems of women, which not only cause them psychological harm but also have an impact on their lives, through the cultural approach of his narrative.

## **Conclusion:**

An examination and analysis of the novel "Allati Taod al-Salalem" using the four approaches of "Elaine Showalter" theory revealed that Hamed effectively imbued women with a sense of identity through the creation of a feminine literary piece, the use of feminine language techniques, and an awareness of women's social and cultural issues. Further it substantiates the feminine nature of Showalter's work through the high frequency of its components. With his feminine language, the author has raised important and deep concerns about women in the form of biological, psychological and cultural issues.
